JOURNEYMEN WAGE RATES

EFFECTIVE OCTOBER 1, 2026 – JUNE 30, 2027

Current rate of pay is **\$44.15** per hour. Vacation pay of **\$3.05** and Target Fund contributions of **\$1.00** per hour is added to the **\$44.15**, making the total taxable gross hourly wage **\$48.20**. After calculating the gross pay, which includes **\$3.05** per hr. and **\$1.00**, deduct payroll deductions, all applicable taxes, **vacation (\$3.05 per hour)** and the **Dues Check-Off (plus Target Fund) of \$4.68 per hr.** The vacation, Dues Check-Off and Target Fund are included in the benefit fund purchase. Total Fringe Benefit package per hour is **\$40.34**.

Contractors are to pay the following fringe benefits:

APPRENTICE PROGRAM SCHEDULE OF WAGES & FRINGE BENEFIT **CONTRIBUTIONS EFFECTIVE OCTOBER 1, 2026 – JUNE 30, 2027**

THE CURRENT RATE OF PAY PER HOUR IS DETERMINED BY THE SCHEDULE BELOW:

THE WAGES FOR AN APPRENTICE SHALL BE AS FOLLOWS:

LEVEL 1 0-1000 HOURS WORKED	\$22.33 per hour
LEVEL 2 1,001-2000 HOURS WORKED	\$26.79 per hour
LEVEL 3 2001-3000 HOURS WORKED	\$31.26 per hour
LEVEL 4 3001-4000 HOURS WORKED	\$35.72 per hour

THE EMPLOYER SHALL DEDUCT THE APPROPRIATE HOURLY DUES CHECK-OFF AMOUNT FROM THE WAGES OF ALL APPRENTICES.

If an employer is signed under an Association's Collective Bargaining Agreement, that Association's rate will be added onto the Employer's benefits purchase.

- BCA members benefit contribution is \$.50 per hour.
- Wall & Ceiling members benefit contribution is \$.15 per hour.
- Concrete Industrial Fund contribution is suspended – This \$.10 per hour is instead being added to Journeymen wages
